1. All vendors must be set up and ready for business with a recommendation to be open by Noon on Tuesday and remain open until dusk (7PM) each day of Fair July 25th through Aug 1st closing at 7pm.

2. All vendors are recommended to be open during all busy times of fair. A Fair Schedule will be provided to all vendors. Busy times are typically 8AM to 7PM. Arrangements may be made with approval from the Fair Manager prior to Fair.

3. The Crook County Fair Board, Crook County or the Crook County Commissioners will not be responsible for any articles exhibited by the lessee. Security will be provided each night; however, lessees should take ALL necessary precautions to avoid damage or theft of his/her property.

4. Lessee is responsible for all licenses, permits, insurance, fees and taxes. Please call the City of Sundance about obtaining a vendor permit.

5. FOOD VENDORS: Vendors are responsible for any and all permits. FOOD VENDORS will NOT allow their gray or black tanks to leak, be emptied or otherwise soil the ground at CCF. FOOD VENDORS will remove their trailer to dump tanks or remove their trailer when asked upon releasing any fluids/water on the ground in proximity to the public or other vendors.
