

## **NOTICE OF INTENT TO HOLD A PUBLIC HEARING ON THE CROOK COUNTY JR. LIVESTOCK SALE POLICY, DRESS CODE, MINI CATTLE**

Be advised the Crook County Fair Board intends to approve and adopt the Jr. Livestock Sale Policy, Dress Code, Mini Cattle

**On Monday January 5th, 2026 at the hour of 6:00 pm, the Board of Crook County Fair will hold a public hearing in the 4-H Shooting Sports Building, Crook County Fairgrounds, Sundance, Wyoming, so all interested parties may present written or oral comments on the proposed approval and adoption of the Crook County Fair Jr. Livestock Sale Policy.**

Written comments may be submitted to the Crook County Fair Manager prior to the hearing at P.O. Box 473, Sundance, WY 82729.

**After the public hearing, the Board of Crook County Fair Board shall take the matter under advisement to consider comments, may set an additional public hearing, may modify the proposed regulation based upon public comment and may then vote to approve and adopt the Crook County Fair Jr. Livestock Sale Policy, Dress Code, Mini Cattle**

Reasonable accommodation will be provided for any person who has a disability who may wish to participate in this hearing, if they provide reasonable notice to the Crook County Fair Manager of their disability and the accommodations requested.

Adding Mini Cows to Fair

***Cort moved to allow Mini cattle into the 2027 Crook County Fair with the following stipulations mini cattle entering the Market beef must be under the minimum of 48", under 1100 lbs. to qualify as a mini subject to classification at weigh-ins but must be over a year old, under 2 years of age to be allowed to sell, Nate seconded, all ayes, motion carried***

Moving December's meeting to December 2<sup>nd</sup>

Cort moved to move the December 1<sup>st</sup> Fair board meeting to December 2<sup>nd</sup>, Nate seconded, all ayes, motion carried.

Sale Check for 2024

Discussion was held. It was decided that there was no policy in place and the check will be issued.

Cort moved to limit the cashing of checks to 90 days from the day of issue from the state bank for sale checks, Nate seconded, all ayes, motion carried.

### Dress Code

Discussion was held. Policy below

***Youth Exhibiting animals at the Crook County Fair are expected to showcase their animals with pride and professionalism. All youth must dress for success, proper attire is required as the following nice dress shirts, nice pants (without holes), and closed toe shoes for safety. For FFA Showmanship you must follow FFA Official dress, which includes Official FFA Blue Jacket, White collared shirt or blouse, Official FFA tie or scarf, Black slacks or pants, black closed toes or as stated by their FFA Advisor.***

### Sale Policy

Jasmyne read over the revision of the sale policy from the County Attorney found below.

**The Seller /Exhibitor understands that the sale committee and Buyer are not responsible for the well-being of livestock held and reserved by the Seller/Exhibitor for State Fair. Sellers that choose to participate in State Fair do so with the understanding that if the livestock is not delivered live to the Buyer or their designated processor, that the sale will be considered null and void. The sale committee recommends but does not require livestock held and reserved for State Fair to be insured to protect the Seller/Exhibitor's investment.**

Discussion was held and it was decided that the new policies on the Jr. Livestock sale, Dress Code and adding Mini cattle to the 2027 Crook County Fair should have a public hearing. Those hearings will be held on December 2<sup>nd</sup> and January 5<sup>th</sup> during the Regular Crook County Fair Board meetings. Jasmyne will send out the notice.
