4-H/FFA Horse Show Practice Announcement

Beginning November 8th, there is a mandatory meeting at 10AM. Dec-May every third Saturday of the month will be designated for Horse Show Practice exclusively for enrolled 4-H and FFA members.

Participation in these sessions is limited to those currently enrolled in a 4-H Horse project or FFA program. These practices are free of charge for eligible members. 4-H Members have to pass or have passed a Safety Cert to Participate.

The first practice will include a mandatory meeting at 10:00 AM to review rules, the event schedule, and participation guidelines and sign contracts/waivers.

If you wish to have more ride time outside of this practice you are to pay full membership to use the barn. NO EXCEPTIONS!!

Any other Saturday or Sunday you must reserve time to ride.

- NO MORE THAN 4 HOURS PER INDIVDUAL/FAMILY on weekends, NO MORE THAN 2 HOURS ON WEEKDAYS!
- Please also remember the 4 PM to 6 PM Time Slots: From Monday to Thursday, families with JR High/ High School Students can reserve the 4 PM to 6 PM time slot only once per week. This period is prioritized for those families with children preparing for Rodeo Season, ensuring everyone gets at least one weekly slot during this time.
 - REMEMBER, YOU CAN ALWAYS RIDE WITH ANOTHER FAMILY TO MAKE THE MOST OF OUR SHARED SPACE.
