Lonny moved to approve the agenda, Justin seconded, all ayes, motion carried.

Brian Mills asked about changing market steers from Keaton to Jaylin. Lonny moved to make an exception for the Mills' to exchange one market steer from Keaton to Jaylin who's steers are listed as a fair project and allow to sell, Justin seconded, all ayes, motion carried.

Tyler Lindholm talked about the FFA Alumni Association. The group would like to have concession sales with beer sales during the rough stock rodeo. They would also like help from the Fair Board with paying for a band during the 4H/FFA BBQ on Friday. Lonny moved to approve \$3,000-\$1500 from entertainment budget and \$1500 from Friends of Fair-to go to the FFA Alumni Association to have their concession, prizes, and dance for the kids, Justin seconded, all ayes, motion carried. Lonny moved to accept the concession stand with beer sales for the youth rough stock rodeo, Terri seconded, 2 ayes, 1 nay, motion carried.

Lonny moved to approve the minutes from the June 7, 2021 meeting, Justin seconded, all ayes, motion carried.

Carolyn gave the Entertainment Committee report. The remaining entertainment checks will need to be ready before fair starts.
